# The History of the Chaplet of The Divine Mercy From DivineMercy.org

In 1935, St. Faustina received a vision of an angel sent by God to chastise a certain city. She began to pray for mercy, but her prayers were powerless. Suddenly she saw the Holy Trinity and felt the power of Jesus' grace within her. She found herself pleading with God for mercy with words she heard interiorly:

Eternal Father, I offer You the Body and Blood, Soul and Divinity of Your dearly beloved Son, Our Lord Jesus Christ, in atonement for our sins and those of the whole world; for the sake of His sorrowful Passion, have mercy on us. (*Diary*, 475)

As she continued saying this inspired prayer, the angel became helpless and could not carry out the deserved punishment (see 474). The next day, as she was entering the chapel, she again heard this interior voice, instructing her how to recite the prayer that our Lord later called "the Chaplet." This time, after "have mercy on us" were added the words "and on the whole world" (476).

From that time on, she recited this form of prayer almost constantly, offering it especially for the dying.

In subsequent revelations, the Lord made it clear that the Chaplet was not just for her, but for the whole world. He also attached extraordinary promises to its recitation.

He encourage souls to say the Chaplet which I have given you (1541). Whoever will recite it will receive great mercy at the hour of death (687). When they say this Chaplet in the presence of the dying, I will stand between My Father and the dying person, not as the just Judge but as the Merciful Savior (1541).

Prayed on ordinary rosary beads, The Chaplet of The Divine Mercy is an intercessory prayer that extends the offering of the Eucharist, so it is especially appropriate to use it after having received Holy Communion at Holy Mass. It may be said at any time, but our Lord specifically told St. Faustina to recite it during the nine days before the Feast of Mercy (the first Sunday after Easter). He then added: "By this Novena, [of Chaplets] I

will grant every possible grace to souls." (796)

It is likewise appropriate to pray the Chaplet during the "Hour of Great Mercy" — three o'clock each afternoon (recalling the time of Christ's death on the cross). In His revelations to St. Faustina, Our Lord asked for a special remembrance of His Passion at that hour.

Pope Leo XIV's Message to U.S. Pilgrims: A Call for Christian Unity

During a recent pilgrimage titled "From Rome to New Rome," Pope Leo XIV met with fifty Greek Orthodox, Byzantine Catholic, and Latin Catholic pilgrims at the serene Castel Gandolfo. Among the pilgrims were notable figures such as Archbishop Elpidophoros and Cardinal Tobin. The atmosphere was filled with anticipation as the pope prepared to deliver his address, which would emphasize the pursuit of unity and charity among Christian communities.

The timing of this meeting was significant, coinciding with the 1700th anniversary of the Council of Nicaea, a cornerstone in Christian doctrine that affirmed Jesus's divinity. Pope Leo XIV highlighted this historical milestone, praising the Nicene Creed as a unifying liturgical element across Christian traditions. He noted that this year, both Eastern and Western churches celebrated Easter on the same day, which he called a "providential coincidence."

In his address, Pope Leo XIV extended peace greetings to Patriarch Bartholomew and expressed hope for future collaboration in commemorating Nicaea's anniversary. He reflected on the historical events of the 1054 Great Schism and celebrated the 1965 gesture by Pope Paul VI and Patriarch Athenagoras, who lifted mutual excommunications. This act of reconciliation was a significant step towards healing the divisions within the Christian community.

The pope's message was imbued with a spirit of spiritual unity. He invoked the spirit of Pentecost, urging believers to return to Jerusalem spiritually—"the City of Peace"—and become bearers of hope and healing. His words resonated deeply with the pilgrims, who felt a renewed sense of purpose and commitment to fostering ecumenical friendship.

As the meeting concluded, the pilgrims left Castel Gandolfo with a sense of inspiration and determination. Pope Leo XIV's message had beautifully woven doctrinal history with an appeal for unity and charity, leaving an indelible mark on all who were present.



# Let Religious Freedom Ring

In its 2024-2025 term, the Supreme Court addressed several cases with significant implications for religious freedom and the relationship between church and state. A key

ruling involved a unanimous decision affirming that denying a Catholic charity a tax exemption granted to other religious groups constitutes religious discrimination. The Court also ruled in favor of parents seeking to opt their children out of public school instruction that conflicts with their religious beliefs, specifically in the context of LGBTQ+ themes in the curriculum. However, the Court also addressed internet-related cases, retreating from some First Amendment principles in those specific instances.

Key Religious Freedom Cases and Decisions:

# **Catholic Charities Tax Exemption:**

The Court unanimously sided with Catholic Charities in Wisconsin, ruling that denying them a tax exemption, while granting it to other religious groups, was discriminatory. This case highlighted the issue of religious exemptions and whether they should be applied uniformly.

#### **Public School Opt-Outs:**

In a 6-3 decision, the Court ruled in favor of parents in Montgomery County, Maryland, who sought to opt their

children out of certain public school instruction, including LGBTQ+ themed content, due to religious objections. This decision emphasizes the protection of religious beliefs in educational settings.

# Mahmoud v. Taylor:

This case, often cited in discussions about the opt-out curriculum and religious beliefs. The case focused on whether public schools could be compelled to accommodate religious objections to certain lessons.

# Oklahoma Statewide Charter School Board v. Drummond:

The Court did not reach a decision in this case, which involved a Catholic virtual charter school's application to become the first religious charter school. This case highlights the ongoing debate surrounding religious institutions in public education.

# **Religious Liberty in Public Spaces:**

<u>First Liberty Institute</u> is currently involved in a case concerning a man who was prohibited from sharing his faith in a public park, raising questions about religious expression in public spaces.



# The month of July is dedicated to the Precious Blood.

The feast of the Precious Blood of our Lord was instituted in 1849 by Pius IX, but the

devotion is as old as Christianity. The early Fathers say that the Church was born from the pierced side of Christ, and that the sacraments were brought forth through His Blood.

"The Precious Blood which we worship is the Blood which the Savior shed for us on Calvary and reassumed at His glorious Resurrection; it is the Blood which courses through the veins of His risen, glorified, living body at the right hand of God the Father in heaven; it is the Blood made present on our altars by the words of Consecration; it is the Blood which merited sanctifying grace for us and through it washes and beautifies our soul and inaugurates the beginning of eternal life in it."

The Church reminds us of the first drops of blood that flowed for our redemption on the day when Jesus was circumcised.

It is night on Mount Olivet, and the moon is shining. We see the holy face crimsoned with blood during the agony in the garden.

Unhappy, despairing Judas casts the blood-money down in the temple. "I have betrayed innocent blood!"

In the scourging chamber we see the Lord in deepest humiliation, under raw strokes the divine Blood spurts out over the floor. Christ is led before Pilate. Pilate shows the blood-covered Body to the crowds: *Ecce homo!* We go through Jerusalem's streets following the bloody footsteps to Golgotha. Down the beams of the Cross blood trickles. A soldier opens the sacred side. Water and Blood.
